Approval for the Temporary Residential Occupation of Land will be given for a maximum of six (6) months only and extensions of time (for an additional six month period) must be applied for via the re-submission of a Temporary Residential Occupation of Land Application Form along with a further payment of the subscribed fee. To qualify for an extension the applicant must prove to Council's satisfaction that adequate progress has been made on the construction of the main dwelling house. The total period approved will only be extended to eighteen (18) months at which time the Approval will be revoked.
